

### **Treasurer's Report**

Please see attached. Officer O'Shea reported that some bicycle repairs and uniform items were purchased during the past month through the Bicycle Fund.

### **Homeless Services**

Officer O'Shea shared the attached flyers, describing what Police can and cannot do with regard to people experiencing homelessness as well as services that are available to them. Please share the flyers, especially with area businesses.

There is a new encampment of 115 individuals at 15<sup>th</sup> & Locust under the PATCO line. Captain Hooven has been in touch with Liz Hersh about it. "Tenants" must be given 30 days' notice of eviction. There is hope the area will be posted by March 1, 2021, and that the individuals will be able to be placed into beds once the encampment is resolved.

Officer have been trained in identifying categories of people experiencing homelessness, for example, panhandlers and persons with mental illness. Their goal is to link at least 30 percent to services and/or housing.

### **Racing on the Parkway/JFK/Disruptive Vehicular Behavior**

Please continue to report incidents to 911. Officer O'Shea reported that red-light cameras are coming per the City Council President's Office. Parks and Recreation continues its efforts. There is hope that there will be headway before the warmer weather approaches.

### **Bars, Area Restaurants and Nightclubs Report**

Officer O'Shea reported that there is an initiative to gather bar and restaurant owners together with Police for a question-and-answer period, so that the police can support and encourage reopening and help restaurants succeed (for instance, by keeping panhandlers away). Jonathan Hunter indicated that many of the guidelines and restrictions are conflicting, especially with regard to outdoor seating.

### **Crime Report**

Officer O'Shea reported that, since the last meeting, there have been:

- 5 robberies with 1 arrest;
- 4 residential burglaries with 1 arrest; and
- 22 thefts from autos with 1 arrest.

Officer O'Shea reported that property and violent crimes have been up over the past two-week period.

There was a carjacking in the 6<sup>th</sup> District which spilled over to the 9<sup>th</sup> District, the evening of February 15, 2021, in the area of 17<sup>th</sup> and Vine. The 17- and 19-yearold suspects have been

arrested and are in custody. One was shot by someone with a permit to carry a firearm during the course of the incident.

Please see the attached flyer provided by Officer O'Shea to deter theft of catalytic converters.

The January 26, 2021 meeting of the 9<sup>th</sup> Police District Advisory Council (PDAC) was held via Zoom and called to order at 5:03 pm by Chester Wichowski, Chairman.

**OFFICERS OF THE MONTH:** Deferred.

**SECRETARY'S REPORT:** The minutes for the December 29, 2020, meeting, submitted by Colleen Walsh and previously distributed via email, were approved.

**TREASURER'S REPORT:** The treasurer's report for the period since our last meeting, submitted by Treasurer Wendy Gosfield and previously distributed via email, was reviewed. The January 26, 2021 balances are as follows: **Total** balance of \$27,067.36, consisting of: **Bicycle Fund** \$20,893.04 with \$2,806.96 expenses for bike repairs and equipment (5 different vendors); **9<sup>th</sup> District** \$3,452.08 with receipts of \$250 from The Philadelphian Condo Association and \$2,500 in expenses for Brother's Catering for a meal for 9<sup>th</sup> District ; and **PDAC** \$2,722.24, including a receipt of \$250 from The Philadelphian Condo Association.

**P.A.L. CENTER UPDATE:** No report.

**PROJECT H.O.M.E/HOMELESS UPDATE:** No rep from Project Home. Code Blue (32 degrees or below) will be in effect this week. Call Outreach to report any individual in need of shelter.

**RACING ON AREA STREETS:** Harriet Williams: Corey Bell from Darrell Clark's office is promising red light cameras in near future in various areas around Art Museum. The Department of Parks and Recreation is working with PD on target programs on weekends, especially on Lemon Hill, and will then move to Art Museum apron in Spring. Signs listing prohibited actions are in the works. Removable barriers may be installed on apron. Call 911 with any illegal behavior.

**B.A.R.N. REPORT:** Jonathan: 25% indoor occupancy now; Mayor Kenney is monitoring COVID numbers to determine if this can continue. No other new information or issues. Local residents are encouraged to patronize neighborhood venues, especially smaller ones without the resources to adjust to restrictions.

**A.D.A. REPORT.** No report.

Chet: PDAC Bylaws are under review by PD law department.

**HUMAN RELATIONS UPDATE:** No report.

**CAPTAIN'S REPORT: P.O. Kiefer** has sent alerts about catalytic converter theft and encourages calls to 911 to report anyone "working" on cars in the street, as that is illegal. Spring Garden, Fairmount, and Logan Square have been the main areas. A few small groups have been apprehended, about 10 in each group. Basically Honda Element and Toyota Prius are targets due to easy access to the converters. There is a spike in gunpoint robberies in Fairmount area, one occurred at 6:00 AM, demanding phone; another at night near 1900 Poplar, demanding purse. More plain clothes men have been placed in that area. Theft from autos is increasing about 6% from last year. Police Explorers usually help post flyers, but they are not currently available to do so due to COVID.

Elaine P inquired about any data comparing this year to last year and requested that violent crime is brought to the forefront of meetings.

P.O. Kiefer reported an arrest related to the assault at 21<sup>nd</sup> and Walnut Jan. 1, AirBnb, and has reliable data on suspect in the 15<sup>th</sup> and Market robbery that escalated to a shooting. Investigation in the 15<sup>th</sup> & Pine St. house party aggravated assault is ongoing.

**COMMUNITY RELATIONS: None.**

**AREA NEEDS:** Elaine asked for any updates on the Clemente playground shooting. Response: In progress with multiple agencies.

Elaine requested any updates on the drug dealing near 1600 block Mt. Vernon. P.O. Kiefer said surveillance continues, suspects caught, with only enough evidence for a ticket. A package thief was arrested in the area. Elaine read notes from 2018 meetings regarding action items taken on by DA and asked if they are still continuing, such as downgrading charges. P.O. Kiefer noted that the PD does not downgrade charges; all other items are for DA's office or family court.

Harriet W inquired about construction equipment left between 19<sup>th</sup> and 20<sup>th</sup> on Parkway. Will follow up with LSNA president.

Wendy noted many thefts from blue mail boxes, asking if the PD is involved. P.O. Kiefer replied that U.S.P.S takes on investigation, but any suspicious activity should be called in to 911.

Fred B. noted that the Kennedy House newsletter is encouraging residents to donate to PDAC with an interest in providing a meal event and would like to pursue information for it.

# Homeless Street Outreach

---

## Purpose

Homeless Outreach Services seeks to identify and track individuals who are chronically homeless in order to assist them into shelter, treatment, or to connect them to other homeless resources.

## Response Calls

Each Outreach team is assigned a designated zone where they focus their outreach efforts. Concerned citizens are encouraged to call the Homeless Outreach Hotline **(215-232-1984)** if they see a homeless individual and are concerned about their safety and/or the safety of those around them. Responses to these calls are given highest priority by the Homeless Outreach Staff.

Outreach relies heavily on citizens to make these calls as they give us a greater sense of where the need for Outreach presence is, allows us to continually evolve our understanding of the needs and challenges of the homeless population in Philadelphia, and gives us greater insight as to the concerns and perceptions of the surrounding neighborhoods and communities.

## The Role of the Outreach Worker

Homeless Outreach continually strives to meet the needs of the communities we work in. However, there are some things that Outreach is legally and/or ethically not permitted to do.

### What we can do:

- Offer housing options for those who are interested
- Transport those who are interested to housing, medical, psychiatric, or other resources
- Call in a 302 (involuntary psychiatric hospitalization) in situations that warrant such action
- Never give up on an individual and continue to engage them until such time that they are ready and willing to get off the street and connected to necessary supports and services

### What we cannot do:

- Outreach cannot physically move people
- Outreach cannot move people's belongings or clean up any trash they may have left behind
- Outreach cannot address illegal behavior (this is a matter for the police)
